Gentlemen:

We have reference to the Ambulatory Blood Pressure Monitoring Program of Doctors John Wallace and William Thornton at the Galveston Hospital. In our letter of April 27, 1979, Del Mar Avionics conveyed to U.T.M.B. the gift of a computer-based data storage, data processing and graphics presentation system we developed in cooperation with Dr. Thornton. The gift was acknowledged in your letter of May 17, 1979. At the time of the gift, our Company also placed on loan to U.T.M.B. the several necessary pieces of equipment to support initial blood pressure monitoring operations which consisted of:

- 1. Del Mar Avionics Pressurometer II, Ambulatory Blood Pressure Recorders, quantity of three (3), Serial Numbers 108, 109 and 247.
- 2. Del Mar Avionics Model 660A Electrocardioscanner, quantity of one (1) each, Serial Number 224.
- 3. Del Mar Avionics Model 1979 Pressurometer Charter, quantity of one (1) each, Serial No. 106.

During 1979, our preplanned and scheduled development of Pressurometer III, a new stand-alone instrument, made the Pressurometer II Recorders unnecessary for U.T.M.B. operations as also is the Model 660A Electrocardioscanner. Subsequently, in 1980 Dr. Thornton purchased from Del Mar Avionics a new Pressurometer III, Serial No. 241, and donated this instrument to U.T.M.B. at the same time that U.T.M.B. purchased, on its own, a new Pressurometer III, Serial No. 236, which is now in use. U.T.M.B. has returned the three (3) Pressurometer II instruments which were on loan from Del Mar Avionics. Missing from the loan return transaction are the Items 2 and 3, listed above, namely the Electrocardioscanner and the Pressurometer Charter. In answering our request for the

return, it has been found that these two items have been inventoried as U.T.M.B. property by misunderstanding through Dr. Wallace. The latter two items are still on our books as Del Mar Avionics property!

We propose to resolve this problem and misunderstanding in the following manner. We acknowledge that Dr. Wallace has a need for the Model 1979 Pressurometer Charter in his report work. Effective immediately, this item will be presented as a gift to U.T.M.B. by Del Mar Avionics as covered by the separate letter enclosed. Regarding the Model 660A Electrocardioscanner, it is now old and worn; we do not see a need for it by Dr. Wallace and request its return to us so that it can be put into better use elsewhere.
